Membership categories

Standard: A member who holds an FAC or who has successfully completed a course in safe handling and use of firearms and who wishes to make use of the NLRC's shooting facilities.

Country: A full member primarily resident in Isle of Wight, Devon, Dyfed, Gwynedd, Clwyd, Cheshire, South Yorkshire, Humberside, or further away from Bisley. Pays 75% of full fee and has voting rights.

Overseas: A member whose main residence is overseas. Pays 25% of full fee and has no voting rights.

Over 70: A full member over the age of 70. Pays 50% of full fee and has voting rights.

Under 21: A full member aged over 14 but under 21 on 1st January of the relevant year. Pays 25% of full fee and has no voting rights.

Under 25: A full member aged over 14 but under 25 on 1st January of the relevant year. Pays 50% of full fee and has voting rights.

Under 28: A full member aged over 14 but under 28 on 1st January of the relevant year. Pays 50% of full fee and has voting rights.

Scholar: A member in full-time education. Pays 25% of full fee and has no voting rights.

Youth: A member aged over 8 but under 14 on 1st January of the relevant year. Pays 10% full fee and has no voting rights.

Family: A member eligible for Youth membership, who is the child or ward of a member. Pays 5% full fee and has no voting rights.

Provisional: A shooting member who does not hold a FAC, or is not a full member of another Home Office Approved fullbore club, or does not have relevant police/military service to qualify for full membership.

Social: A member not entitled to make use of the Club's shooting facilities. Pays 25% of full fee and has no voting rights.
